Established in 1999, the Bill of Rights Institute (BRI) supports secondary school teachers of American history, civics, and social studies. By providing free digital resources to educators and students, and professional development programs for educators, BRI is committed to educating for self-governance. In doing so, BRI inspires the rising generation to champion the ideals expressed in our nation's founding documents and to strive for their full realization. In 2020 BRI's digital platform, which includes its websites, YouTube channel, and social media outlets, served 7.21 million users, with a total engagement time of more than 397,000 hours.
